A079 is a Cosmetic Product which contains: Aqua, Sodium Laureth Sulfate, Sodium Chloride, Cocamide DEA, Glycol Stearate, Glycerin, Parfum, Linalool, Hexyl Cinnamal, Benzyl Alcohol, Chloromethylisothiazolinone, Methylisothiazolinone, Triethylene Glycol, Propylene Glycol, Magnesium Chloride, Magnesium Nitrate, CI 45100.
